Equimundo Center for Masculinities and Social Justice (Equimundo) draws on its core approaches to focus on three thematic pillars: (1) Caring Men: Redefine caregiving as a meaningful aspect of men's lives; (2) Healthier Boyhoods: Fostering environments that support boys and young men to live diverse, equitable, and healthy masculinities, and (3) Social Connection: Working to foster healthy, pro-social interactions and cultivate inclusive allies in civic spaces. Two of our flagship initiatives are the Global Mencare Campaign, which promotes men's involvement as equitable, non-violent caregivers across over 50 countries, highlighting the positive impact of active and engaged fathers on family well-being and gender equality; and the Global Boyhood Initiative (GBI), active across five (5) continents and which believes that shifting inequitable and restrictive ideas about gender affect individuals from a young age is crucial to achieving gender equality.
